Clerk/Treasurer- Phyllis Baranski: Phyllis Baranski stated the May PPT money has been deposited. Phyllis stated the Summer Rec. program has started this week and is going well. Phyllis thanked the Council for allowing her to attend Clerk's Conference last week. Phyllis stated the auditors are here for part of this week and again for part of next week. Phyllis stated a Parks and Rec. 5 year Plan correction was submitted with the assistance of Agnes Kosinski.

Police-Chief Scott Jobes: Scott Jobes stated complaints are even this year with last year at 319. Scott stated he participated in the Lions Kid's Day two weekends ago and handed out 75 water bottles and various trinkets. Scott stated the suspect in the car break-ins was arrested, jailed, out on bond, and is charged with 5 felonies, 2 or 3 misdemeanors, and another warrant as well. Scott stated the security cameras are working throughout town and he was able to track and catch a suspect who drove a truck that threw stone onto the walking path and soccer fields. Scott stated the culprit cleaned up the mess he made, as well as a couple other community service projects in lieu of a ticket.

DPW-Superintendent Lonnie Schulz: Agnes Kosinski gave the DPW report in Lonnie's absence. Agnes stated the water spigot is installed at the gazebo, the landscaping is installed at the gazebo and Ackerman Park, the front bathroom will be getting a new roof, and the number one pavilion will be painted. Dan Armbruster stated the street sweeper is broken and will be in the shop for repairs for a few weeks.

Ambulance-Coordinator Cheyenne Rathje- Matt Lewis gave the Ambulance report in Cheyenne's absence. Matt stated that Cheyenne has safely made it to Oregon, where she will be nursing for the next three months.
