Phyllis stated the Huron County Community Foundation sent our annual payment from the Woelfle-Moettli Fund to be used for beautification of the parks and downtown.

DPW-Superintendent Lonnie Schulz: Lonnie Schulz stated the sweeper should be fixed by the end of the week. Lonnie stated the Mullen St. sign is installed.
