Department Reports

Clerk/Treasurer-Phyllis Baranski: Phyllis stated since last meeting she has finished up taxes, assisted with the Ambulance EMT class recruiting, and filed the Ambulance rig insurance claim. Phyllis Baranski also stated the Village was not chosen for the Sparks Grant.

Ambulance-Coordinator Beth Swartzendruber- Beth stated there were 17 billable runs in September. The Ambulance rig hit a deer on the way back from the hospital. Beth stated it is already fixed, but during the repair she was able to borrow rigs from Sebewaing and Central Huron. Beth stated the EMT class that we are sending 12 students to will be held on Tuesdays from 8:30A.M-4:30P. M. for 14 weeks. It is an accelerated class and should have students taking the State test in February or March. Discussion on the class.

DPW-Superintendent Lonnie Schulz: Lonnie stated the asphalting behind the hall and on Barb Thompson Dr. will be completed in the next few weeks. The concrete sidewalk work around town is completed. Lonnie stated the aluminum picnic tables will be delivered on Friday. The wooden picnic tables will be donated to the Community Club for use during Autumnfest. Lonnie stated the Zoning Ordinance updates are being reviewed by the County. Everything else is going well.

Police-Chief Scott Jobes: Scott Jobes stated he is at 100 more complaints this year than last year. He is at 551 complaints so far this year comparted to 449 complaints at this time last year. Scott stated the cameras are installed with one on the Youth Center pointing at the main intersection, one on the Village Hall pointing north, and eight in Ackerman Park. Scott stated he would like to have 2 more cameras in Ackerman Park by the Historical Society buildings and one more on Village Hall pointing south. Scott stated he was awarded a Huron County Community Foundation grant for \$500 and the Elkton Community Club donated \$500 to the police department as well. Scott intends to use both donations for youth activities such as Halloween and Christmas events.
