Clerk/Treasurer- Phyllis Baranski: Phyllis Baranski stated the Workman's Comp Audit items have been submitted for the annual review. Nietzke & Faupel are scheduled for the Village audit June 9th-13th. Summer Rec. sign up ends on Friday May 16th. Phyllis stated the final payment for W. McKinley St. has been disbursed to Nicol & Sons. Phyllis stated Lee's Landscaping will start the three areas of planting beds next week with completion by Memorial Day weekend.

Ambulance-Coordinator Cheyenne Rathje- Cheyenne Rathje stated there were 26 runs in April with 21 of them billable. Cheyenne purchased a new IPad from Walmart at a cost of \$400, since the other one quit working. Cheyenne stated the Ambulance received \$500 from the United Way.

DPW-Superintendent Lonnie Schulz: Lonnie Schulz stated the spring hydrant flush has been completed. Lonnie stated they have been busy with park improvements and maintenance. Lonnie stated the front bathrooms will be getting a new roof this year.

Police-Chief Scott Jobes: Scott Jobes stated complaints are up from last year with 261 for this year compared to 253 last year. Scott stated he has been investigating car larcenies over the last week. Scott stated with the assistance of Tower Automotive, Pigeon Police Dept., Huron Co. Sheriff Dept., and part time officer Warren Kuhl, the suspect was arrested and jailed on Sunday night. Scott stated that today he was assisting Cass County with the location of a missing endangered female in our area. Scott stated she was located and safe.

Committee Reports: Agnes Kosinski stated the Elkton Lion's Kids Day is May 31st, Lion's concession stand is June 7th and 8th, and that Music in the Park starts June 14th. Agnes stated the DDA is buying 4 new benches for downtown, new lamp post banners, and a drinking fountain/bottle filler/dog water bowl for Ackerman Park. Agnes also stated the DDA will be placing the downtown flower pots soon.
